

## Development of Garden Festival Site to proceed

At a meeting in early September '08, with Stephen Barnes of Langtree and David Rolinson of Spawforth, Chairwoman Andrea Spyropoulos and Hon. Sec. Reg Cox discussed the plans for the development of the Garden Festival Site, as a result of the Approval by the Secretary of State.

The Development Agreement between Langtree McLean and Liverpool City Council contains several obligations which must be complied with by Langtree McLean before any development commences. In addition, the planning consent which has recently been granted by the Secretary of State also features a large number of conditions, many of which must be satisfied before any work commences. These include a Garden Management Strategy and a Gas Management Strategy among other things. RRA Officers were concerned that the economic down turn may adversely affect the work. However, Langtree Maclean outlined that there is a lot of work that has to be carried out prior to any works commencing on site and it could be about two years before this preparatory work is completed. It is hoped that during this period, the economy will have improved. Andrea Spyropoulos stated that the last thing residents wanted was a great mass of unoccupied apartments and houses on our doorstep. Though we are looking forward to the clearing and development of the parkland.

It was agreed that Langtree Maclean will continue to work through their obligations with Liverpool City Council and will keep us informed as the work proceeds, and consult Riverside Residents Association if necessary.

is working correctly. It is not unknown for the 9v battery to be taken out, to replace a dead battery in another piece of equipment, and not to be replaced.

The Fire Service will replace, or provide new smoke alarms to any resident living in Merseyside, some with ten-year batteries, and recommend that they are fitted to all homes. This is a free service. They also recommend that you shut all doors on the ground floor, leading to the stair case, when going to bed, as this means that if a fire should start accidentally, whilst you sleep, the smoke alarm will warn you, the fire will be contained, and you will be able to make your escape.

## Report on Mersey Estuary Forum 2008. 3rd July 2008

I attended the Forum in the Maritime Museum.

The proceedings were introduced by **Prof. Peter Batey** of Mersey Basin Campaign. There were many speakers on various aspects of matters concerning the estuary, from Southport, through to Salford and also the Wirral coast. The main concerns were the quality and treatment of water and also the development of the area.

**Walter Menzies** of Mersey Basin Campaign, which has four areas: Liverpool, Greater Manchester, Cheshire and Ribble. They sponsored the competition for the replacement of the Radar Tower at Seaforth, running a competition that drew 92 entries worldwide. The chosen design was voted for overwhelmingly by the residents of Seaforth, in a local poll, and was also the choice of the "Panel of experts". The proposed Observatory can be viewed at [www.merseyobservatory.com](http://www.merseyobservatory.com) Well worth a look. It is hoped that the building will be open to the public by 2012.

**Ian Hamilton**, Hon Sec of Crosby Residents Association, spoke of their involvement and support for the Observatory and also the problems of Blue/Green algae in the Sailing Club lake and the development of the Sailing Club.

**Louise Morrisey** from Peel Holdings presented their ambitious plans for the Mersey, including the development of the unused docks north of the Pier Head into a "Shanghai" type tower city and ditto for the other side of the river. The last undeveloped piece of Liverpool is the Speke coast, where Peel have cleaned up the drug dealing and the area is now safe for families to visit. Another of their schemes is a proposed Tidal Fence, probably installed in our part of the river, to produce electricity.

**Tom Workman** of Liverpool Sailing Club showed how they have built up a really beautiful club house, largely by members efforts. It is down near Speke Hall and I for one propose to go and have a look.

**Dr Clemency Fisher** of World Museum Liverpool showed their plans for the "Museum of Liverpool", the steel frame of which is now complete and being coated with steel, ready for the Limestone cladding. The museum should be open to the public by 2010 - 2011.

**David Backhouse** of Liverpool Organic Gardeners showed his proposal for the Garden Festival Site, "Liverpool Earthship", which is an education centre for things green, Built largely from recycled materials, including a wall made from car tyres and drinks cans, it has a moat for protection. In the question session

after, I asked if he had funding for the scheme and what were his proposals for the existing garden. He stated that "funding was difficult" and proposes to leave the garden in its wild state. If he can't build on the Garden Festival Site, he'll look for another site on Merseyside. I've known David for many years, he designed the interesting Cavern Walks Centre and I wish him luck with his scheme.

**Sarah Elberton** of the The Environment Agency presented their proposals for Merseyside, but I must have been either fascinated by it all, or nodded off, for I have no notes on what was said and can't remember owt. Sorry!

**Steve Butler** of City of Liverpool Swimming Club, told of plunging into the murky waters of the river and the docks. When they started, many years ago, they had to chuck away their swim trunks on emerging, as they were covered in oil and all sorts of toxic substances. Now they swim in clear water in the docks and they can even see where they are going in the river.

**Jean Grant**, another friend and fellow artist, explained the Pool Project, an interesting scheme looking for volunteers to define areas on unused land in Liverpool. More info at: [www.poolproject.co.uk](http://www.poolproject.co.uk)

**Peter Morton** of Mersey Waterfront was very supportive of the Langtree/ Maclean scheme for the Garden Festival Site. Mersey Waterfront will provide £1.5 million towards the development of the park at the site.

**Mark Turner** of Mersey Basin Campaign, gave an up-date on their involvement in the area, the improvement in water quality and United Utilities efforts for the community. It's something you don't think about as a layman, but when a "development" is proposed, say the Tower Scheme for the north docks, a huge amount of planning has to go into providing water and sewage, before the project starts. Otherwise you are paddleless and up the proverbial creek. The website [www.rpx.org.uk](http://www.rpx.org.uk) has a lot of info.

3rd to 12th October 2008 is Mersey Basin Week and there is an excellent "coffee table" book "Mersey the river that changed the World", available at any good bookshop.
